Notification on denial of entry for trucks without VBS announcement

Dear business partners,

we would like to inform you that on **26.11.2019** we are introducing a measure of **refusal of trucks without VBS announcement of entry**. The driver, without announcement of entry, will be rejected at the port entrance and asked to arrange an announcement of entry.

When introducing the measure, we remain tolerant of announcements that do not have the appropriate time of entry within the same day, the arrival of the vehicle is premature or is delayed. However, you are kindly requested to follow the directions and arrivals within the hours announced.

Drivers who use one-time permits to enter the port are advised to check the entry announcement status before arriving at the port entrance. At the external truck terminal, we continue to provide assistance in entering VBS data for the driver.
